

ICE DATA Service Facilitator Application Form

ICE Data will review each service facilitator application form individually and reserves the right decline any request to redistribute or display ICE Market Data. The minimum criteria that ICE Data will require are:

- A commercial agreement in place between the Service Facilitator and an Authorised ICE Data Redistributor. Upon termination of the ICE Data / Authorised Redistributor agreement, any Service Facilitator approval from ICE will immediately terminate.
- The Authorised Vendor must contract directly with the Subscriber and not the Service Facilitator; the Authorised Vendor will be liable for all Market Data Exchange fees, and any other fees that apply.
- The Authorised Vendor must control all entitlements of Subscriber access and provide data directly to the end client; the Service Facilitator will not be permitted to onward supply ICE Market Data in any form.
- The Authorised Vendor must report all real-time accesses to ICE on a monthly basis, though when reporting for a Service Facilitator it must be clearly identifiable, by reporting against a preagreed company name, that the accesses for via a Service Facilitator device.
- The Authorised Vendor will take full responsibility for the display, accuracy and content of ICE Data on the Service Facilitators device.
- The Service Facilitator will supply to ICE a full product listing and product overview of all devices that will display ICE Data.
- Access to ICE data by Service Facilitator will be fee liable apart from pre-agreed accesses stated in the ICE Data / Vendor contract or on separate agreement with ICE.
- The Service Facilitator may not database or retain any ICE Data pricing information.
- The Service Facilitator may not use ICE Market Data in any form to derive their own pricing.
